1. OVERVIEW

FGV DIREITO SP is pleased to announce the selection process for a six-month Post-Doctoral Fellowship. The **Global Fellowship Program** seeks to attract talented young researchers interested in advancing their scholarship in Brazil. The Program provides the opportunity to develop high-skilled research, offering financial support and a vibrant academic environment. The **Global Fellowship Program** is a crucial part of FGV DIREITO SP **Global Fellows Program**, designed to strengthen the international academic environment at FGV DIREITO SP bringing together researchers from all over the world.

2. ELIGIBILITY

Candidates may be of any nationality, including Brazilian, and must have completed a Doctoral Program in Law or in another correlated area prior to the start of the fellowship, i. e., before August 1st. Although desired, knowledge of Portuguese is not required.

3. APPLICATION

- ii. Recommendation Letter
- iii. A publication (or working paper)
- iv. Research proposal (up to 5000 characters)

4. RESEARCH PROPOSAL

Candidates should prepare a short **research proposal** considering the following possibilities:

- a) original research on a topic in Brazilian law;
- b) comparison of Brazilian developments with those in another country, done in collaboration with FGV scholars or in accordance with the FGV research agenda;
- c) a research project unrelated to Brazil but of interest to scholars in Brazil.

5. RESPONSIBILITIES

Fellows are expected to advance their scholarship and develop their professorial skills by engaging in the intellectual life of FGV DIREITO SP. Responsibilities of Global Fellows may include the following:

- a) Develop research within a FGV DIREITO SP Research Center, aiming at publishing the results in an academic journal;
- b) Participate in direct class activities supervised by a senior members of the faculty;
- c) Conduct seminars, in English, to FGV DIREITO SP students, professors and researchers;
- d) Engage in the organization of research activities and events, such as conferences, workshops and joint publications.

6. RECRUITMENT

The applicants must submit, on time pre-established, to FGV DIREITO SP's International Affairs Coordinator, all documents required for his/her hiring. The foreign candidates shall be responsible for obtaining visas and permits required for residency in Brazil.

Approved candidates in the selection process will have to stay at FGV DIREITO SP, and cannot be absent during the fellowship period without the consent of the Program's Coordinator.

7. SCHOLARSHIP AMOUNT

One-semester scholarship: R\$ 36.000,00, paid in 6 (six) installments of R\$ 6.000,00.

8. FELLOWSHIP DURATION

Period – 1 August 2020 to 31 January 2021

The scholarship duration may be exceptionally extended for additional six months if there is mutual interest of the FGV Direito SP and the fellow.
